

DECLARATION OF MICHAEL B. CHESAL UNDER 28 USC § 1746

1. My name is Michael B. Chesal. I am a member of the law firm of Peretz Chesal & Herrmann, PL, and make this declaration based on personal knowledge.
2. I am an attorney licensed with the Florida Bar (No. 775398).
3. I have served as counsel of record for Rise International Group L.L.C. ("Rise") since at least as early as April 3, 2002.
4. On or about June 24, 2003, I caused to be recorded an assignment executed on April 3, 2002, from Northside Development, Inc. to Rise, with the Assignment Recordation Services Division (the "Assignment to Rise").
5. The Assignment to Rise covered and was recorded against two registrations, namely Reg. Nos. 1882761 and 1860625 for the mark DERMASIL (the "DERMASIL Registrations").
6. The records of the Assignment Recordation Services Division indicate that over three years after execution of the Assignment to Rise, on June 20, 2005, an assignment executed on May 8, 2005 was recorded as to 388 properties, which incorrectly included the DERMASIL Registrations (the "Wild Assignment"). *See* Reel/Frame 3177/0626.
7. The records of the Assignment Recordation Services Division further indicate that the Wild Assignment purported to assign the DERMASIL Registrations from Conopco, Inc. ("Conopco"), which had previously owned the DERMASIL Registrations and assigned them to a third party in 1994.
8. As a result of the Assignment to Rise, Rise should be the record owner of the DERMASIL Registrations, and the Wild Assignment, which purports to involve such registrations, should be disregarded and the records of the Assignment Recordation Services Division should be corrected accordingly.

I declare under penalty of perjury that the foregoing is true and correct.
