**TRADEMARK ASSIGNMENT**

ASSIGNOR agrees that it will execute any formal papers as requested by ASSIGNEE to effect the assignment herein, and in the event ASSIGNOR is unable to execute or otherwise refuses to execute any said documents, ASSIGNOR hereby authorizes and grants power of attorney to ASSIGNEE to execute said documents on ASSIGNOR's behalf.
