RELEASE AND TERMINATION OF SECURITY INTEREST (TRADEMARKS)

THIS RELEASE AND TERMINATION OF SECURITY INTEREST (TRADEMARKS) (this "Release"), dated as of August 17, 2011, by California Bank & Trust, a California banking corporation ("Lender"), in favor of Continental Exchange Solutions, Inc., formerly known as RIA Telecommunications, Inc. ("Company"), with reference to the following facts:

RECITALS:

WHEREAS, pursuant to that certain Loan and Security Agreement, dated as of April 25, 2005, among RIA Envia, Inc., Company and Lender (the "Loan and Security Agreement"), and that certain Intellectual Property Security Agreement, dated April 25, 2005, between Company and Lender, Company granted to Lender a security interest in all right, title and interest of Company in and to the Trademarks, as defined below, to secure the performance of all obligations of Company to Lender set forth in the Loan and Security Agreement and related loan documents and the payment of all amounts due thereunder; and

WHEREAS, the security interest granted to Lender was recorded in the United States Patent and Trademark Office on July 15, 2005 at Reel 3121 and Frame 0820; and

WHEREAS, Lender has agreed to release and terminate its security interest in the Trademarks;

RELEASE AND TERMINATION:


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby releases and terminates its first-priority security interest in and lien on all of the United States trademarks of Company more particularly described on Exhibit A attached hereto (collectively, the "Trademarks") and Lender hereby assigns and transfers to Company all of Lender's right, title and interest in and to each of the Trademarks and the trademark registrations, goodwill, proceeds and any other rights related thereto, effective as of the date set forth hereinabove.
