**ONE:** The name of this corporation is Xirgo Technologies, Inc.

**TWO:** The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of California other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the California Corporations Code.

**THREE:** The name and address in the State of California of this corporation's initial agent for service of process is Roy Schneider, Esq., 5425 Everglades Street, Ventura, California 93003.

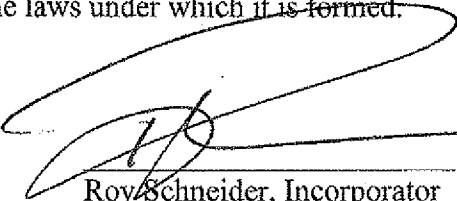
**FOUR:** This corporation is authorized to issue only one class of shares of stock; and the total number of shares which this corporation is authorized to issue is twenty-five thousand (25,000).

**FIVE:** In any action for breach of directors' duties pursuant to California Corporations Code Section 309, the liability of the directors of the corporation for monetary damages shall be eliminated to the fullest extent permissible under California law.

**SIX:** This corporation is authorized to provide indemnification of agents (as defined in Section 317 of the California Corporations Code) for breach of duty to the corporation and its stockholders through by-law provisions or through agreements with the agents, or both, in excess of the indemnification otherwise permitted by Section 317 of the California Corporations Code, subject to the limits on such excess indemnification set forth in Section 204 of the California Corporations Code.

**SEVEN:** The name of the converting entity is Xirgo Technologies, LLC; it is a limited liability company formed in the State of Delaware. The converting entity's California Secretary of State file number is 200612210203. The foreign entity is authorized to effect the conversion by the laws under which it is formed, and it has approved a plan of conversion or other instrument to effect the conversion as required by the laws under which it is formed. The conversion has been approved by the number or percentage of applicable holders of interest of the foreign entity as is required by the laws under which it is formed.
