

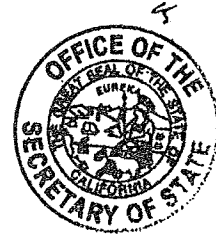

**CERTIFICATE OF AMENDMENT
OF
ARTICLES OF INCORPORATION
OF
BIOCOMPARE, INC.**

The undersigned, Paul Gatti and Andy Miller, certify that:

1. They are the duly elected President and Secretary, respectively, of Biocompare, Inc., a California corporation.

2. ARTICLE ONE of the Articles of Incorporation of this corporation is amended to read as follows:

"ONE: The name of this corporation is CompareNetworks, Inc."


3. The foregoing amendment of the Articles of Incorporation has been duly approved by the Board of Directors.

4. The foregoing amendment of Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902, California Corporations Code. The total number of outstanding shares of the corporation is 11,549,832 shares of Common Stock and 5,514,572 shares of Series A Preferred Stock. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required under the law and the Articles of Incorporation in effect at the time of this amendment was more than 50% of the outstanding shares, and more than 50% of the outstanding shares of Series A Preferred Stock, voting as a separate class.


