
TRADEMARK ASSIGNMENT AGREEMENT



The parties further agree that in the event the Assignee decides to sell all rights, titles, and interests in the above mentioned Trademark, the Assignor will have the first right to purchase back such rights, titles, and interests in the Trademark.

The Assignee further agrees that the manufacturing of all products associated with the above mentioned Trademark will remain exclusively with Q.U.I.C.K., INC., unless otherwise agreed in writing by both parties.
