GRANT OF SECURITY INTEREST
IN UNITED STATES TRADEMARK

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, JOINSON INDUSTRIES, INC., a corporation organized under the laws of the State of Georgia ("Grantor") with principal offices at 5944 Peachtree Corners East, Norcross, Georgia, 30071, hereby grants to PNC BANK, NATIONAL ASSOCIATION, as lender and as agent ("Grantee"), a security interest in (a) all of Grantor's right, title and interest in and to the United States trademark number 2587593 registered on July 2, 2002 (the "Mark"), (b) all proceeds and products of the Mark, (c) the goodwill of the businesses with which the Mark is associated and (d) all causes of action arising prior to or after the date hereof for infringement of the Mark or unfair competition regarding the same.

Upon termination of the Credit Agreement as provided therein, Grantee shall execute, acknowledge, and deliver to Grantor an instrument in writing releasing the security interest in the Mark acquired under this Grant.

This Grant has been granted in conjunction with the security interest granted to Grantee under the Credit Agreement. The rights and remedies of Grantee with respect to the security interest granted herein are as set forth in the Credit Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Credit Agreement, the provisions of the Credit Agreement shall govern.


