RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE, dated August 17, 2011 (this "Release"), is made by TRISTATE CAPITAL BANK, a Pennsylvania state chartered bank with a place of business at 301 Grant Street, 27th Floor, Pittsburgh, Pennsylvania (the "Secured Party"), of a Credit and Security Agreement, dated March 31, 2009 and recorded on May 1, 2009 in the records of the United States Patent and Trademark Assignment Branch at Trademark Reel/Frame 003980/0908 (the "Security Agreement"), among the Secured Party, GABRIEL PERFORMANCE PRODUCTS, LLC, an Ohio limited liability company ("Gabriel"), and GABRIEL HOLDINGS, LLC, a Delaware limited liability company (together with Gabriel, collectively, the "Debtor").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release its security interest in the Trademarks, and discharges, quit claims and relinquishes unto the Debtor (in each case without recourse and with representation or warranty) any and all rights, title and interest it has in and to the Patents.
