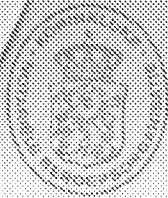

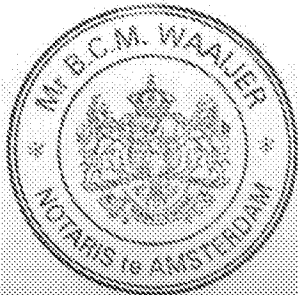

The qualifications to which this confirmation is subject are as follows:

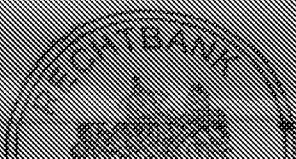

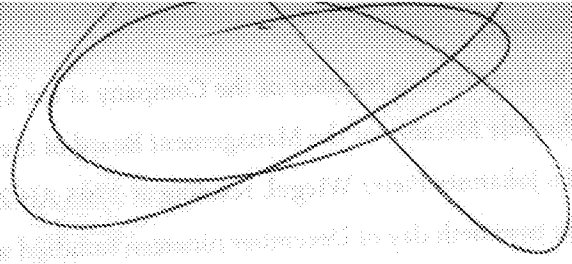
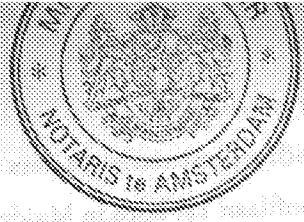
