RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of August 18, 2011, by AMALGAMATED BANK OF CHICAGO ("Lender"), in favor of ZENITH ADMINISTRATORS, INC., a Delaware corporation ("Grantor").

WITNESSETH:

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of October 30, 2009 made by Grantor in favor of Lender, Grantor granted a security interest in certain of its trademarks and service marks listed on Exhibit A attached hereto (collectively, the "Trademarks") to Lender to secure certain debts and obligations owing from Grantor to Lender;

WHEREAS, Grantor has requested that Lender (a) terminate and release the liens and interests of Lender in the Trademarks, and (b) execute and deliver evidence of such termination and release for filing in the United States Patent and Trademark Office; and

WHEREAS, Lender has agreed to such release and termination;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby (i) releases and terminates its security interests in and to the Trademarks, and (ii) reassigns to Grantor all right, title and interest of Lender in and to the Trademarks.
