Assignee is a successor to the ongoing and existing business of Assignor to which the Trademark pertained.

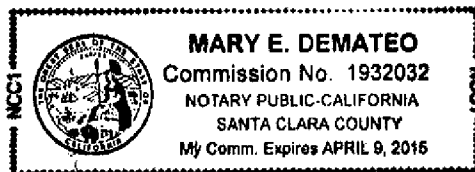
