## **RELEASE OF SECURITY INTEREST**

This Release of Security Interest, effective as of April 21, 2011 (the "Effective Date"), is made by ARES CAPITAL CORPORATION (as successor in interest to Allied Capital Corporation), as "Collateral Agent" for the "Lenders" (as defined in the "Security Agreement" defined below) with a principal place of business at 245 Park Avenue, 44th Floor, New York, NY 10167 (the "Agent"), in favor of CITY TOWING INC, a Nevada corporation, with a principal place of business at 9550 Bormet Drive, Mokena, IL 60448 (the "Debtor").

WHEREAS, on January 22, 2008, Debtor and Agent entered into a certain Trademark Collateral Security and Pledge Agreement (the "Security Agreement") which provided for the grant by Debtor to Agent of a security interest in the trademark described on the attached Schedule A (the "Trademark"); and

WHEREAS, on March 4, 2008, Agent recorded in the Patent and Trademark Office the Security Agreement, evidence of its security in the Trademark.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, as of the Effective Date, Agent hereby (1) releases, discharges and relinquishes its security interest in and lien on the Trademark, as listed on Schedule A, and (2) reassigns to Debtor all right, title, and interest that Agent may have had in and to the Trademark, including all goodwill of the business associated with the Trademark, and the applications for and registrations thereof, and all renewals and extensions thereof, and any and all causes of action for infringement thereof, and any and all royalties for any licenses thereof. Agent specifically acknowledges that the Security Agreement is no longer effective as to the Trademark, and that Agent does not own any rights to or have any ownership interest or claim in the Trademark.

Agent acknowledges and confirms that the terms and conditions of this Release of Security Interest shall be effective evidence of the release of the security interests in the Trademark.
