**TERMINATION AND RELEASE OF
SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (the "Release") is made this 22nd day of August, 2011 (the "Release Date") by RBS Citizens, N.A., a national banking association and successor to Citizens Bank of Massachusetts, a Massachusetts bank ("Citizens Massachusetts"), as Agent (the "Secured Party"), for the benefit of Gerber Scientific Inc., a Connecticut corporation, and Gerber Scientific International Inc., a Connecticut corporation (collectively, the "Debtors").

WHEREAS, the Debtors have entered into that certain Loan and Security Agreement, dated as of October 31, 2005 with Citizens Massachusetts (as at any time prior to the date hereof amended, supplemented or otherwise modified, the "2005 Loan and Security Agreement");

WHEREAS, the Debtors have entered into that certain Amended and Restated Credit and Guaranty Agreement, dated as of March 1, 2011, with the Secured Party (as at any time prior to the date hereof amended, supplemented or otherwise modified, the "2011 Credit Agreement"), and the Debtors have entered into that certain Amended and Restated Security Agreement, dated as of March 1, 2011 with the Secured Party (as at any time prior to the date hereof amended, supplemented or otherwise modified, the "2011 Security Agreement" and together with the 2005 Loan and Security Agreement, the "Security Agreements");

WHEREAS, pursuant to the Security Agreements, the Debtors have granted to the Secured Party security interests in and to certain assets of the Debtors, including, without limitation:

(i) The United States patents, patent applications and patent licenses set forth in Exhibit A hereto, together with all reissues, divisions, continuations, continuations-in-part, extensions and reexaminations thereof, and all rights therein provided by international treaties or conventions (the "Patents");

(ii) The United States trademark and service mark registrations, applications and licenses set forth in Exhibit B hereto (the "Marks");

(iii) The copyrights, United States copyright registrations and applications and copyright licenses set forth in Exhibit C hereto (the "Copyrights"); and

(iv) any and all claims for damages for past, present and future infringement, misappropriation or breach with respect to the Patents, Marks and Copyrights, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages and any and all proceeds of the foregoing (together with the Patents, Marks and Copyrights, the "Intellectual Property");

WHEREAS, the Secured Party has filed with the United States Patent and Trademark Office (the "USPTO") notices of security interests in the Patents, and such notices of security interests have been recorded at the USPTO at Reel 016976/Frame 0965 on January 9, 2006, at Reel 016987/Frame 0139 on January 9, 2006 and at Reel 017097/Frame 0668 on January 10, 2006;

WHEREAS, the Secured Party has filed with the USPTO notices of security interests in the Trademarks, and such notices of security interests have been recorded at the USPTO at Reel 3222/Frame 0348 on January 6, 2006; and

WHEREAS, the Secured Party has filed with the United States Copyright Office (the "USCO") notices of security interests in the Copyrights, and such notices of security interests have been recorded at the USPTO at Volume 3533/Document 215-217.

NOW THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party agrees as follows:

1. Release of Security Interest. Effective as of the Release Date, the Secured Party hereby irrevocably and forever terminates, releases and discharges any and all security interests in the Intellectual Property granted by the Debtors under the Security Agreements.

2. Recordation of Release. The Secured Party understands and agrees that this Release may be recorded by or for the Debtors with the USPTO and the USCO and in any other offices where notices of the Secured Party's security interests have been filed and/or the Intellectual Property has been collaterally assigned to the Secured Party.



The Secured Party further agrees to execute any other documents and take any further action reasonably necessary in any state, country or jurisdiction that the Debtors or their respective designees, successors or assigns may reasonably require to effect the intent and purpose of this Release, provided that all such documents are to be prepared by counsel to the Debtors and the cost and expense of such documents and actions shall be borne solely by the Debtors.

4. Capitalized Terms. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the 2011 Credit Agreement and/or the Security Agreements, as applicable.
