This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Termination and Release") is executed as of August 24, 2011, by NewStar CP Funding LLC ("NewStar"), in favor of ShelterLogic LLC (f/k/a ShelterWorkz LLC, f/k/a OPAC, LLC), a Delaware limited liability company, ShelterLogic Holdings LLC (f/k/a ShelterWorkz Holdings LLC, f/k/a ShelterWorkz, LLC), a Delaware limited liability company, ShelterLogic International LLC (f/k/a ShelterWorkz International LLC, f/k/a OPCAC, LLC), a Delaware limited liability company and North American A L.L.C., a Delaware limited liability company (collectively, the "Pledgors").


For goods and valuable consideration, the receipt of which is hereby acknowledged:
