RELEASE OF SECURITY INTEREST IN TRADEMARKS

The Secured Party represents and warrants that: (i) it has the full power and authority to execute this Release of Security Interest in Trademarks; and (ii) it has not assigned, transferred, restricted or otherwise encumbered its rights under the Security Agreement.


