TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARK RIGHTS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Release"), effective as of August 25, 2011 is made by U.S. BANK NATIONAL ASSOCIATION, a national banking association with an office at 60 Livingston Avenue, St. Paul, Minnesota 55107, as trustee, (the "Trustee") for the holders of the Notes described below (the "Noteholders") in favor of SMART MODULAR TECHNOLOGIES, INC., a California corporation with an office at 39870 Eureka Drive, Newark, California 94560 (the "Pledgor").

W I T N E S S E T H:

WHEREAS, Pledgor, Trustee, Smart Modular Technologies (WWH) Inc., an exempted company organized under the laws of the Cayman Islands ("Parent") and certain other subsidiaries of Parent have entered into that certain Indenture, dated as of March 28, 2005 (as may be amended, the "Indenture"), governing Parent's \$125,000,000 Senior Secured Floating Rate Notes due 2012 (the "Notes").

WHEREAS, in connection with the Indenture, pursuant to the Collateral Assignment of Trademarks (Security Agreement), dated as of March 28, 2005 between the Pledgor and the Trustee (as amended, amended and restated, supplemented and/or otherwise modified from time to time, the "Security Agreement"), the Pledgor pledged and granted to the Trustee for the benefit of the Noteholders a continuing security interest in the Trademark Collateral. As used herein, the term "Trademark Collateral", shall mean all of the Pledgor's right, title and interest of every kind and nature in the trademark registrations and applications listed on Schedule A hereto.

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on March 29, 2005 at Reel/Frame 3054/0748.

WHEREAS, the Pledgor has requested that the Trustee release and reassign any and all right, title and interest it may have in the Trademark Collateral, and the Trustee has agreed to do so; and

WHEREAS, the Trustee has duly authorized the execution, delivery and performance of this Release.

NOW THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Security Agreements, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Trustee hereby states as follows:

SECTION 1. Release of Security Interest. The Trustee does hereby release, relinquish, terminate and discharge its security interest in, to and under the Trademark Collateral and reassigns any and all right, title and interest that it may have in or to the Trademark Collateral to the Pledgor.

SECTION 2. Further Assurances. The Trustee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby.

SECTION 3. Counterparts. This Release may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.

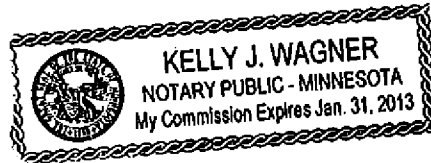
