GRANT OF SECURITY INTEREST (TRADEMARKS)

The undersigned, BOGATIN ENTERPRISES LLC, a Kansas limited liability company (the "Grantor"), is obligated to RBS CITIZENS, N.A., as Administrative Agent (in such capacity, the "Secured Party"), under the Guarantee Agreement, dated as of the date hereof (as amended, restated, supplemented or otherwise modified from time to time, the "Guarantee Agreement"), by and among LeCroy Corporation (the "Borrower"), the Grantor, the other subsidiaries of the Borrower from time to time party thereto and the Secured Party. The Grantor is a party to the Security Agreement, dated as of the date hereof (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), by and among the Borrower, the Grantor, the other subsidiaries of the Borrower from time to time party thereto and the Secured Party.

The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Secured Party with respect to the security interest in the Collateral made and granted hereby are set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

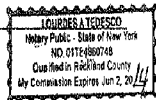
