absolutely.

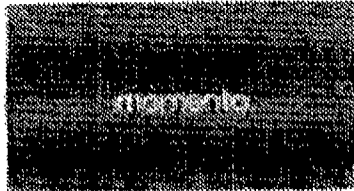

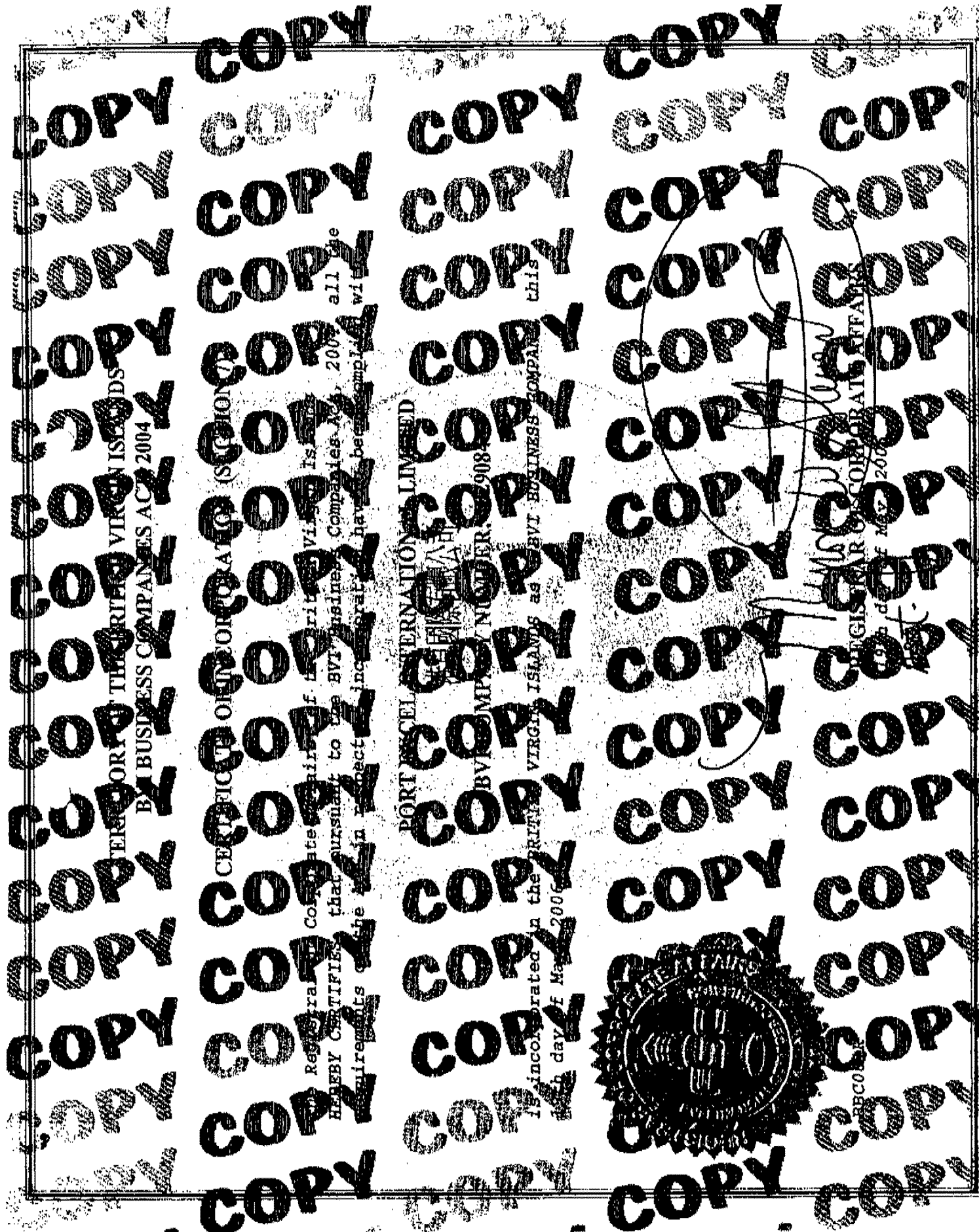
