**ASSIGNMENT**

**TRADEMARK**

ASSIGNOR also assigns ASSIGNEE the right to action for past, present and/or future infringement(s) in addition to defense of the TRADEMARKS. ASSIGNOR additionally assigns the ASSIGNEE the right to recover for damages and profits for past, present, and/or future infringements of the TRADEMARKS.

**ASSIGNOR HEREBY AGREES** to transfer to ASSIGNEE, its successors, assigns and legal representatives, without further remuneration, a like interest in and to any improvements, derivative works, and applications based thereon, growing out of or relating to the common law trademark and from any ensuing registration from any application(s) filed for the TRADEMARKS; and to provide all reasonable assistance and execute any papers, as desired by ASSIGNEE, its successors, assigns and legal representatives, to preserve, acquire and/or perfect ASSIGNEE's full protection and title in and to the TRADEMARKS and any improvements.

ASSIGNOR agrees to execute and deliver at the request of the ASSIGNEE, all necessary papers, instruments, and assignments, and to perform any other reasonable acts that ASSIGNEE may require in order to vest all of ASSIGNOR'S rights, title, and interest in and to the TRADEMARKS to the ASSIGNEE and/or provide evidence to support any of the foregoing in the event that such evidence is necessary to effectuate this assignment, to the extent such evidence is in the possession or control of the ASSIGNOR.

In the event that any information was sought for the TRADEMARKS, and was not available as of the execution of this Assignment, ASSIGNOR hereby authorizes and requests any attorney associated with the Law Offices of Alozie N. Etufugh, PLLC, to insert in this assignment the requisite information and/or submit papers that may be necessary or desirable in order to comply with the rules of the United States Patent & Trademark Office for the recordation of this document.
