ASSIGNMENT OF INTELLECTUAL PROPERTY

THIS ASSIGNMENT OF INTELLECTUAL PROPERTY (the "Assignment") is made as of August 18, 2011, by and among Aderant CompuLaw, LLC, a Delaware limited liability company (the ("Assignee"), and CompuLaw LLC, a California limited liability company ("Assignor"), under the following circumstances:

BACKGROUND

This Assignment is being executed and delivered pursuant to that certain Asset Purchase Agreement entered into as of August 18, 2011, by and among Assignee and Assignor and, for purposes of Sections 4.8 (Principal Stockholder Covenants), 8.1 (Indemnification), 8.3 (Press Releases and Announcements), 8.9 (Tax Matters), 8.11 (Non-Competition, Non-Solicitation and Confidentiality), 9.2 (Notices) and 9.10 (Governing Law) and Article 6 (Representations and Warranties of the Principal Stockholders), each of David J. Kalmick, Lois Kalmick and CompuLaw, Inc. (each a "Principal Stockholder," and collectively, the "Principal Stockholders") ("Purchase Agreement"). All initially capitalized terms used but not otherwise defined in this Assignment shall have the meanings assigned to such terms in the Purchase Agreement.

NOW, THEREFORE, in consideration of the mutual promises contained in this Assignment, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows

1. Assignor hereby assigns to Assignee all of its right, title and interest in, to and under the intellectual property set forth in Exhibit A attached hereto (the "Intellectual Property") and all pending or inchoate actions or claims related to any of the foregoing, including the right to sue for past infringement or breaches of contract.

2. Assignee hereby accepts this assignment.

3. Assignor agrees that on written request and without further consideration, but at the sole cost and expense of Assignee, to render all reasonably requested assistance to Assignee to establish or protect Assignee's rights in and to the Intellectual Property.

4. This Assignment may be executed in one or more counterparts, and each signatory hereto may sign on a separate counterpart, each of which shall be deemed an original and all of which, when taken together, shall constitute one instrument. Signature pages may be detached from the counterparts and attached to a single copy of this Assignment to physically form one document. Facsimile signature pages will be acceptable and shall be conclusive evidence of execution.

5. Both Assignor and Assignee request that the Commissioner of the United States Patent and Trademark Office and the head of the United States Copyright Office, or any analogous officials of other governmental authority, record and file this assignment with respect to the applicable Intellectual Property.

6. The assignments and assumptions made in this Assignment are made solely to the extent required at Closing by the Purchase Agreement. This Assignment is expressly made

subject to the Purchase Agreement, and any conflict between the terms of this Assignment and the terms of the Purchase Agreement shall be construed in favor of the Purchase Agreement.
