TRADEMARK ASSIGNMENT

Background

- A. Munitio ("Assignor"), a California corporation with its principal place of business at 302 Washington Street, Ste. 151, San Diego, California, manufactures and sells earphones and cabling and other related accessories for earphones (collectively, the "Goods").
- B. NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee all of Assignor's right, title and interest in and to the Marks, the Applications and the Registration, and the goodwill and common law rights appurtenant thereto, and Assignee does hereby accept this assignment.


