**TERMINATION AND RELEASE OF TRADEMARK
SECURITY AGREEMENT**

This Termination and Release of Trademark Security Agreement (the "Release") is conveyed as of August 31, 2011, by GENERAL ELECTRIC CAPITAL CORPORATION, a Delaware corporation, as administrative agent for itself and other Lenders and L/C Issuers under the Credit Agreement referred to below (in such capacity, the "Administrative Agent"), in favor of SCHNELLER LLC, a Delaware limited liability company ("Schneller").

WHEREAS, reference is made to that certain Credit Agreement, dated as of June 28, 2007 (as amended, amended and restated, or otherwise modified to the date hereof, the "Credit Agreement"), by and among Schneller, the other Credit Parties party thereto, the Lenders and L/C Issuers set forth therein, and Administrative Agent.


WHEREAS, the records of the United States Patent and Trademark Office reflect that the Administrative Agent and Schneller entered into a Trademark Security Agreement dated as of June 28, 2007 (the "Agreement"), and recorded on August 9, 2007 at Reel 3598 and Frame 0299, under which Schneller granted to the Administrative Agent a security interest in Schneller's interest in the trademark registrations and trademark applications listed on the attached Schedule A (collectively, the "Marks").

WHEREAS, the Administrative Agent seeks to make a record of the Administrative Agent's release to Schneller of the security interest granted in the Marks by Schneller in favor of the Administrative Agent pursuant to the Agreement and the Guaranty, Pledge and Security Agreement executed concurrently with the Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, the Administrative Agent hereby releases, discharges, and relinquishes the security interest granted in the Marks by Schneller in favor of the Administrative Agent pursuant to the Agreement.
