Section 2. Consideration: The consideration for this Assignment shall be the sale of business assets from Assignor, and/or its affiliates, to Assignee.

Section 3. Intellectual Property: All copyrights, patents, trade secrets or other intellectual property rights associated or derived from with the IP, including any ideas, concepts, techniques, inventions, processes contained therein, shall be for the sole and exclusive property of Assignee and Assignor retains no rights to the IP.

Section 4. Further Assurances. The Assignor shall from time to time after the date hereof at the request of the Assignee, and without further consideration, execute and deliver to it such additional instruments as the Assignee shall reasonably request to evidence more fully the assignments made under this Agreement.

Section 5. Entire Agreement. This Agreement shall be deemed the entire agreement by and between Assignor and Assignee with regard to the subject matter of this Agreement and


supersedes any and all prior oral or written agreements to the contrary.




