DEED OF ASSIGNMENT

THIS ASSIGNMENT is made the 15th day of FEB 2011 between:

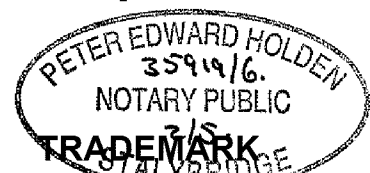
NOW THEREFORE IT IS AGREED AND DECLARED as follows:
