RELEASE OF SECURITY AGREEMENT

Bank of America, N.A., as successor by merger to LaSalle Bank National Association, as Agent (as defined in the Security Agreement, as defined below) (together with its successors and permitted assigns, the "Secured Party"), for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, hereby, on behalf of itself and the Lenders: (A) terminates, cancels and releases, without recourse or warranty, any security interest and any other lien or other encumbrance it or any Lender has in or to any right, title, or interest of abc/LTD Group, L.P., a Delaware limited partnership ("abc/LTD"), abc Distributing, LLC, a Delaware limited liability company ("abc"), and LTD Commodities LLC, a Delaware limited liability company ("LTD", and together with abc/LTD and abc, the "Grantors"), in, to or under any of the trademarks, trademark registrations, trademark applications, and trademark licenses set forth in Schedule I attached hereto, or any other trademarks, trademark registrations, trademark applications, or trademark licenses or any other trademarks (collectively, the "Trademark Collateral") subject to that certain Security Agreement, dated as of February 3, 2003 (as amended, restated, supplemented, or otherwise modified from time to time, the "Security Agreement"); and (B) re-assigns, without recourse or warranty, to each Grantor, on behalf of itself and the Lender, any right, title or interest it or any of the Lender may have in, to or under any of the Trademark Collateral.

All capitalized terms used but not otherwise defined herein have the meanings given to them in, as applicable, the Security Agreement or the Credit Agreement, dated as of February 3, 2003 and amended and restated as of July 26, 2006, among the Grantors, the Agent and the Lenders (as amended, restated, supplemented, or otherwise modified from time to time, the "Credit Agreement").

The Secured Party shall, at the Grantors' expense, execute and deliver any and all documents and other instruments as may be reasonably requested by the Grantors to more fully and effectively effectuate the purposes of this agreement.
