

Pursuant to the provisions of §53-13-4, NMSA 1978, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE ONE

The name of the Corporation is Vickie R. Wilcox, P.C., and the NMSCC# is 4169496.

ARTICLE TWO

The following amendment to the Articles of Incorporation was adopted by the Board of Directors of the corporation on January 22, 2011, in the manner prescribed by the New Mexico Business Corporation Act: **Article I of the Articles of Incorporation has been amended to change the name of the corporation to "Wilcox Law Firm, P.C."**


ARTICLE THREE






