RELEASE OF SECOND LIEN TRADEMARK SECURITY INTEREST

THIS RELEASE dated as of August 31, 2011 by CREDIT SUISSE AG (formerly known as CREDIT SUISSE), as collateral agent (in such capacity, the "**Collateral Agent**") for the Secured Parties. Terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement referred to below or the Guarantee and Collateral Agreement referred to below, as applicable.

A. Reference is made to (a) the Second Lien Credit Agreement dated as of June 15, 2007 (as amended, supplemented or otherwise modified prior to the date hereof, the "**Credit Agreement**"), among Specialized Technology Resources, Inc., a Delaware corporation (the "**Borrower**"), STR Holdings, Inc. (f/k/a STR Holdings, LLC), a Delaware corporation ("**Holdings**"), the lenders from time to time party thereto and Credit Suisse AG (formerly known as Credit Suisse) as administrative agent and as Collateral Agent, (b) the Second Lien Guarantee and Collateral Agreement dated as of June 15, 2007 (as amended, supplemented or otherwise modified prior to the date hereof, the "**Guarantee and Collateral Agreement**"), among Holdings, the Borrower, the subsidiaries of the Borrower from time to time party thereto (together with Holdings and the Borrower, the "**Grantors**") and the Collateral Agent, and (c) the Second Lien Trademark Security Agreement dated as of June 15, 2007 (together with the Guarantee and Collateral Agreement, the "**Security Agreements**"), among Holdings, the Borrower and the Collateral Agent. Pursuant to the Security Agreements, the Grantors granted a security interest to the Collateral Agent, for the benefit of the Secured Parties, in, among other things, the registered trademarks, trademark licenses and trademark applications of the Grantors set forth on Schedule I hereto (the "**Trademarks**"), which security interest was recorded with the United States Patent & Trademark Office on June 19, 2007 at Reel/Frame 003563/0717.

B. In connection with the repayment of all Indebtedness under and the termination of the Credit Agreement and the release of security interests under the Loan Documents, the Grantors have informed the Collateral Agent of their desire to obtain the release of all right, title and interest of the Secured Parties and each other grantee or beneficiary in and to the Trademarks granted under the Security Agreements.


Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, all the Collateral Agent's right, title and interest (including, without limitation, security interests) in and to the Trademarks pursuant to the Security Agreements shall hereby automatically terminate as provided in the Security Agreements, without any representation or warranty by, or recourse to, the Collateral Agent.

THIS AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH AND BE GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.


