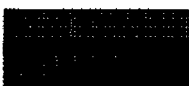


AFFIDAVIT

Charlie San Miguel, having been sworn, states the following:

1. My name is Charlie San Miguel and I am a Senior Legal Counsel for Clockwork IP, L.L.C.
2. I am duly authorized to make this Affidavit.
3. On January 4, 2011, based upon a factual misunderstanding, I executed an assignment transferring U.S. Registration 2972324 to Clockwork IP, L.L.C. from Ultimate Technical Academy, L.L.C. and authorized it to be recorded at the USPTO. The document was recorded as a Change of Name instead of an assignment at Reel 004483 Frame 0492-0495.
4. On August 23, 2011, it was brought to my attention that the aforementioned assignment was made in error and in order to correct the matter, I executed a Nunc Pro Tunc Quitclaim Assignment transferring U.S. Registration 2972324 back to Ultimate Technical Academy, L.L.C. and I submitted the assignment for recordation which was recorded at Reel 004610 Frame 0226. Annette Heller, counsel for Ultimate Technical Academy, L.L.C., has objected to such filing to correct the matter.

5. Accordingly, at the express request of counsel for Ultimate Technical Academy, L.L.C., Annette Heller, both the Assignment dated January 4, 2011 and the Nunc Pro Tune Quitclaim Assignment dated August 23, 2011 executed by me are hereby withdrawn and as such, these two documents are now completely null and void and are without any legal force or effect.

6. Since the original Assignment and the Nunc Pro Tune Quit Claim Assignment are null and void, I am filing this Affidavit so that the record is clear that Ultimate Technical Academy, L.L.C. has been and continues to be the only owner of all rights, title and interest in and to U.S. Registration 2972324 and Clockwork, IP, L.L.C. was not the owner of U.S. Registration 2972324 from January 7, 2011 to August 23, 2011.


