ASSIGNMENT OF TRADEMARKS

This ASSIGNMENT OF TRADEMARKS is effective as of May 16, 2011 between MCI Communications Corporation, a Delaware corporation hereinafter "ASSIGNOR"), and BBG Communications, Inc., a Delaware corporation (hereinafter "ASSIGNEE").

WHEREAS, ASSIGNOR and ASSIGNEE have entered into an Asset Purchase Agreement dated May 9, 2011 (hereinafter "Agreement") wherein ASSIGNEE is purchasing certain property and assets of ASSIGNOR, including certain intellectual property;

WHEREAS, ASSIGNOR is the owner of all right, title and interest in and to the trademarks and the trademark registrations and common law trademark therefor identified in the attached Schedule A (hereinafter "Trademarks"); and

WHEREAS, ASSIGNEE is desirous of acquiring the aforesaid Trademarks, together with the goodwill of the business symbolized by the Trademarks, the aforesaid trademark registrations and common law trademark, that portion of ASSIGNOR's business which is symbolized by the Trademarks, together with the right to file the Trademarks in foreign countries (subject, however, to applicable laws in such foreign countries), and the right to recover damages for any past and future acts of infringement associated with the Trademarks.

NOW, THEREFORE, in consideration of the premises and mutual covenants set forth in the Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR does hereby assign unto ASSIGNEE all right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks, the aforesaid trademark registrations and common law trademark, that portion of ASSIGNOR's business which is symbolized by the Trademarks, together with the right to file the Trademarks in foreign countries (subject, however, to applicable laws in such foreign countries), and the right to recover damages for any past and future acts of infringement associated with the Trademarks.
