NUNC PRO TUNC TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (this "**Assignment Agreement**") is between Kuhlman Electric Corporation, a Delaware corporation having its principal place of business at 101 Kuhlman Boulevard, Versailles, KY 40383 ("**Assignor**") and Kuhlman Manufacturing Corporation, a Delaware corporation having its principal place of business at 101 Kuhlman Boulevard, Crystal Springs, MS 39059 ("**Assignee**").

PREAMBLE

Assignor is the owner of the United States Registered Trademarks listed on Exhibit A attached hereto (the "**Trademarks**"). Assignor and Assignee are parties to that certain Transfer and Assumption Agreement dated as of November 1, 2009 (the "**Agreement**"). Pursuant to the Agreement, Assignor has agreed to assign to Assignee, and Assignee has agreed to assume all of the Assignor's rights, title and interest in and to the Trademarks. Therefore, the parties agree as follows with the intent to be legally bound:

ASSIGNMENT AGREEMENT

Assignor, *nunc pro tunc* as of November 1, 2009, hereby sells, assigns and transfers all of its right, title and interest in and to the Trademarks, and all registrations associated therewith, to Assignee, together with the goodwill of the business associated with each Trademark and with the right to recover and have damages and profits for past infringement of each Trademark.

Assignor does hereby expressly agree that procedures be taken with the United States Patent and Trademark Office singly by Assignee to record the transfer of the Trademarks to Assignee.
