**RELEASE OF SECURITY INTEREST IN  
UNITED STATES TRADEMARK REGISTRATION**

THIS RELEASE OF SECURITY INTEREST is effective this 19<sup>th</sup> day of August 2011, in respect of the security interest described below granted by Alinabal, Inc., a Connecticut corporation (the "Borrower"), in favor of Bank of Boston Connecticut (the "Lender").
