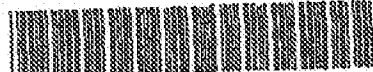

ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company pursuant to the Oklahoma Limited Liability Company Act, hereby executes the following Articles of Organization:

FIRST. The name of the limited liability company is Mazzio's, LLC (the "Company").

SECOND. The period of existence of the Company is perpetual.

THIRD. The street address of the principal place of business of the Company is 4441 South 72nd East Avenue, Tulsa, Oklahoma 74145.

FOURTH. The name and address of the resident agent of the Company in the State of Oklahoma is Bradford J. Williams, Jr., 4441 South 72nd East Avenue, Tulsa, Oklahoma 74145.

FIFTH. The management of the Company is hereby vested in the manager or the managers of the Company.
