TRADEMARK ASSIGNMENT

This Trademark Assignment ("Assignment") is made by and between One Way Street, Inc. ("Assignor") and Dale VonSeggen, Sarah E. VonSeggen and Charles S. Burroughs (collectively the "Assignees") on August 2, 2011.

1. Introduction. Assignee and Assignor are parties to a Consent to Strict Foreclosure, Surrender of Collateral and Release Agreement of even date (the "Consent to Foreclosure"), pursuant to which Assignor agreed to convey to Assignees, and Assignees agreed to accept, the service marks, trademarks and trade names of Assignor (whether or not the foregoing are registered). This Assignment is to document the assignment of the Assignor's registered and unregistered domestic and foreign service marks, trademarks, service mark/trademark applications and trade names listed below.

For and in exchange of the consideration set forth in the Consent to Foreclosure, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agrees as follows:

2. Marks. For purposes of this Assignment, all state, common law, federal and foreign trademarks, service marks and trade names, and registrations with the U.S. Patent and Trademark Office (the "USPTO") and any foreign equivalent of the USPTO, applications for registration of such trademarks, service marks and trade names, whether or not registered and wherever registered including, but not limited to, those marks, names and applications, shown on Exhibit A attached hereto and incorporated herein by this reference, constitute the "Marks".

3. Assignment. Assignor hereby transfers and assigns to Assignees, and Assignees hereby accept the transfer and assignment of, all of Assignor's worldwide right, title and interest in, to and under the Marks, together with the goodwill of the business associated therewith and which is symbolized thereby, all rights to sue for infringement of any Mark, whether arising prior to or subsequent to the date of this Assignment, and any and all renewals and extensions thereof that may hereafter be secured under the laws now or hereafter in effect, the same to be held and enjoyed by Assignees, their successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made.

4. Representations and Warranties. Assignor has full right, title and interest in and to the Marks and has been duly authorized to enter into this Agreement and perform its obligations under this Agreement. The Marks have not been pledged as collateral to any party other than Assignees.

5. Governing Law. Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment shall be governed by and construed in accordance with Colorado law without giving effect to any state's conflicts of laws or choice of law principles.

6. Authority to Sign. By signing below, the undersigned hereby represents and warrants he or she is duly authorized to sign on behalf of Assignor and bind Assignor to the terms of this Assignment.

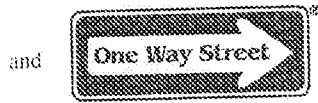

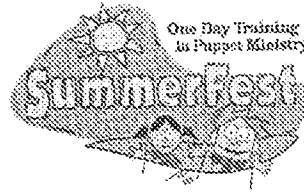

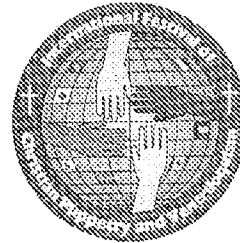
