RELEASE OF SECURITY INTEREST

WHEREAS, pursuant to that certain Patent and Trademark Security Agreement entered into on May 8, 2008 between Country Creek Farms, L.L.C., a Tennessee limited liability company, ("CCF"), and Wells Fargo Bank, National Association ("Wells Fargo"), CCF granted a security interest to Wells Fargo in certain Patents and Trademarks (as defined in the Security Agreement) described therein (the "CCF Secured Property"), and such Security Agreement was recorded within the records of the United States Patent and Trademark Office at Reel 003794, Frame 0871 on Jun 12, 2008; and

WHEREAS, pursuant to that certain Patent and Trademark Security Agreement entered into on May 8, 2008 between W3 Partners, LLC, an Arkansas limited liability company, ("W3"), and Wells Fargo Bank, National Association ("Wells Fargo"), W3 granted a security interest to Wells Fargo in certain Patents and Trademarks (as defined in the Security Agreement) described therein (the "W3 Secured Property"), and such Security Agreement was recorded within the records of the United States Patent and Trademark Office at Reel 003794, Frame 0857 on Jun 12, 2008; and

WHEREAS, Wells Fargo desires to formally release its security interest and all right, title and interest of Wells Fargo in and to the CCF Secured Property and the W3 Secured Property, including without limitation the Trademarks set forth on Exhibit A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Wells Fargo does hereby release and forever discharge and reconvey to CCF all of Wells Fargo's security interest in Wells Fargo's right, title and interest in, to and under the CCF Secured Property and W3 Secured Property, including Wells Fargo's security interest in the trademark registrations set forth on Exhibit A so that it is as if the security interests had never been granted by CCF and W3.

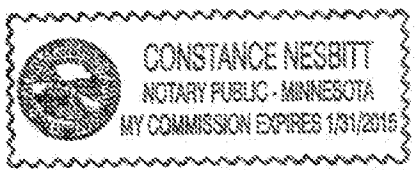
