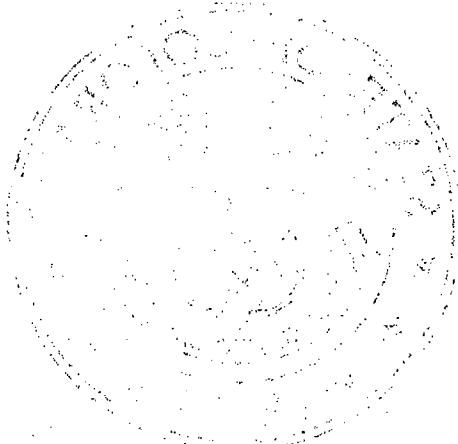

"The domestic entity name of the limited liability company is iTriage, LLC"

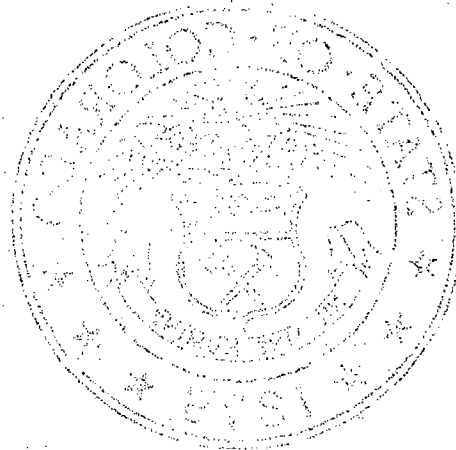
