**FIRST AMENDMENT TO  
ARTICLES OF INCORPORATION  
OF

The undersigned, IPC Acquisition Corp., a Missouri corporation (the "Corporation"), for the purpose of amending the Articles of Incorporation of the Corporation, in accordance with General and Business Corporation Law of Missouri, does hereby make and execute this First Amendment to Articles of Incorporation and does hereby certify that:

1. The name of the Corporation is IPC Acquisition Corp.
2. An amendment to the Corporation's Articles of Incorporation was adopted by the sole shareholder on December 10<sup>th</sup>, 2010.
3. Article FIRST is hereby deleted in its entirety and the following is inserted in lieu thereof:

FIRST. The name of the corporation is IPC Print Services, Inc.

4. The number of shares of stock of the Corporation outstanding was one thousand (1,000) shares of Common Stock, all of which shares of Common Stock were entitled to vote on the amendment.

5. The number of shares of the Corporation voted for the amendment was one thousand (1,000) shares of Common Stock, and the number of shares voted against the amendment was zero (0).

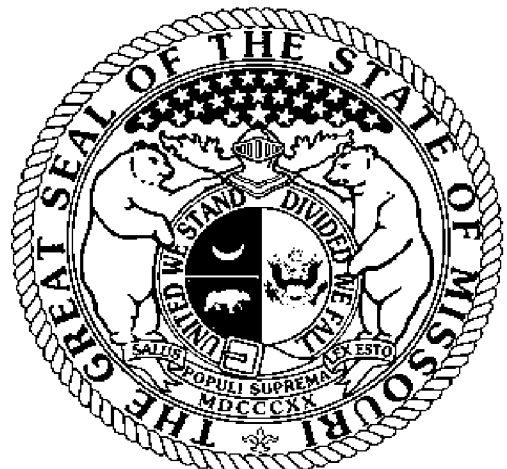
