TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (the "Assignment") dated as of September 13, 2011 (the "Effective Date"), is by and between ArchBrook Laguna Holdings LLC, a Nevada limited liability company, ArchBrook Laguna LLC, a Nevada limited liability company, ArchBrook Laguna West LLC, a Nevada limited liability company, Lehrhoff ABL LLC, a Nevada limited liability company, ArchBrook Laguna New York LLC, a New York limited liability company, Chimerica Global Logistics LLC, a Wyoming limited liability company, and Expert Warehouse LLC, a Nevada limited liability company, (each an "Assignor" and collectively "Assignors"), in favor of SED Lehrhoff, INC., a New Jersey corporation (the "Assignee").

WHEREAS, in connection with the Asset Purchase Agreement between Assignors and Assignee, dated August 15, 2011 (the "Agreement"), Assignors have agreed to assign, sell, transfer, set over, and deliver unto Assignee, among other items, certain Intellectual Property, including trademarks, service marks, trade logos, and other marks and trade or business names relating to the ownership, use, operation, and management of such Intellectual Property;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignors hereby assign, transfer, and convey to Assignee all of Assignors' right, title, and interest in and to the trademarks listed on Schedule A hereto, together with the goodwill of the business connected with the use thereof and symbolized thereby, the registrations thereof and rights of renewal and extension thereof, all common-law rights related thereto, and all causes of action and rights of recovery for infringements, dilutions, or violations of the foregoing prior to the Effective Date (the "Trademarks").
2. Each party acknowledges that this Assignment is a legal, valid, and binding obligation of the warranting party and it has full power and authority to enter into and perform its obligations under this Assignment in accordance with its terms. To the extent this Assignment is inconsistent with any terms or conditions of the Agreement, the terms and conditions of the Agreement shall control.
3. The right, title, and interest in and to each of the Trademarks is to be held and enjoyed by Assignee and Assignee's successors and assigns as fully and exclusively as it would have been held and enjoyed by Assignors had this assignment not been made.
4. Assignors will, without additional consideration, take such further actions and execute promptly such further documents as are necessary to effect and record the assignment herein, including any actions or documents that may be necessary to protect, secure, and vest good and marketable title to the Trademarks in Assignee.
5. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original and all of which shall, taken together, be considered one and the same agreement.


6. This Assignment shall be governed by and construed in accordance with the laws of the State of New York.
