FIRST AMENDMENT TO PATENT AND TRADEMARK SECURITY AGREEMENT

This First Amendment to Patent and Trademark Security Agreement (this "Amendment"), dated as of September 14, 2011, is made by and among GVI Security Solutions, Inc., a Delaware corporation ("GVI Security Solutions"), GVI Security, Inc., a Delaware corporation ("GVI Security," and together with GVI Security Solutions, the "Debtor"), and Wells Fargo Bank, National Association (the "Secured Party"), acting through its Wells Fargo Business Credit operating division.

RECITALS

WHEREAS, GVI Security and the Secured Party are parties to a Credit and Security Agreement, dated as of November 20, 2007 (as amended, supplemented or restated from time to time, the "Credit Agreement") setting forth the terms on which the Secured Party may now or hereafter extend credit to or for the account of GVI Security;

WHEREAS, Debtor and Secured Party entered into that certain Patent and Trademark Security Agreement, dated as of November 20, 2007 (as amended, supplemented or restated from time to time, the "Patent and Trademark Security Agreement"), a copy of which is attached hereto as Exhibit A;

WHEREAS, Debtor has acquired additional Trademarks, which, pursuant to the terms of the Credit Agreement, are Collateral securing the Indebtedness;

WHEREAS, Debtor and Secured Party now wish to amend, modify and supplement the Patent and Trademark Security Agreement, as more particularly set forth in this Amendment.

NOW THEREFORE, in consideration of the premises contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

- 1. <u>Definitions</u>. All capitalized terms used herein and not otherwise defined shall have the same meaning herein as in the Patent and Trademark Security Agreement or the Credit Agreement (as applicable).
- 2. <u>Amendment to Exhibit B.</u> <u>Exhibit B</u> to the Patent and Trademark Security Agreement is hereby amended to add thereto the Trademarks set forth on <u>Annex I</u> to this Amendment.
 - 3. <u>Ratifications; Representations and Warranties.</u>
 - (a) The terms and provisions set forth in this Amendment shall modify and supersede all inconsistent terms and provisions set forth in the Patent and Trademark Security Agreement and, except as expressly modified and superseded by this

Amendment, the terms and provisions of the Patent and Trademark Security Agreement are ratified and confirmed and shall continue in full force and effect.

- (b) This Amendment constitutes a legal, valid and binding obligation of Debtor, and is fully enforceable in accordance with its terms, except as enforceability may be limited by bankruptcy, insolvency, reorganization, moratorium or similar laws and equitable principles affecting the enforcement of creditors' rights generally.
- (c) The execution and delivery of this Amendment and the fulfillment of and compliance with the terms and provisions hereof, will not conflict with, or result in a breach of the terms, conditions or provisions of or constitute a default under any agreement or instrument to which Debtor is now a party or by which Debtor is bound.

4. Miscellaneous.

- (a) This Amendment has been entered into in conjunction with the provisions of and the security interest granted to Secured Party under the Credit Agreement. The rights and remedies of Debtor and Secured Party with respect to the security interests granted herein are in addition and without prejudice to those set forth in the Credit Agreement or the other Loan Documents, all terms and provisions of which are hereby incorporated herein by reference. In the event that any provisions of this Amendment are deemed to conflict with the Credit Agreement or the other Loan Documents, the provisions of the Credit Agreement or the other Loan Documents shall govern.
- (b) This Amendment may be executed in any number of counterparts with the same effect as if all the signatures on such counterparts appeared on one document. Each such counterpart will be deemed to be an original, but all counterparts together will constitute one and the same instrument.


