**ASSIGNMENT AND RELEASE OF
SECURITY INTEREST**

July 26, 2011

This Assignment and Release of Security Interest (this "Release") is dated as of the date first set forth above. Reference is hereby made to that certain Trademark Collateral Security and Pledge Agreement (the "Trademark Security Agreement") dated as of January 18, 2005, by and between Examination Management Services, Inc., a Nevada corporation, ("Assignor"), and Deutsche Bank Trust Company Americas, a New York banking company (the "Collateral Agent"), pursuant to and for the benefit of the Senior Noteholders (as defined therein) recorded with the United States Patent and Trademark Office on _____, 2011, at Reel/Frame No. 3017/0331. Capitalized terms used herein and not otherwise defined shall have the meanings provided therefor in the Trademark Security Agreement.


For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby notifies, acknowledges and agrees with Assignor that (i) the lien on and security interest in the Pledged Trademarks pledged and granted by such Assignor to the Collateral Agent for the ratable benefit of the Senior Noteholders, including, without limitation, the lien on and security interest in the trademarks listed on the attached Schedule A and any after-acquired trademarks, is terminated, released and discharged fully, (ii) the Collateral Agent hereby releases and forever discharges fully all of its right, title and interest in, to and under, and of any kind or nature in the Pledged Trademarks granted, assigned or conveyed pursuant to the Trademark Security Agreement, and (iii) any right, title or interest of the Collateral Agent in, to and under the Trademark Collateral shall hereby cease and become void. The Collateral Agent hereby retransfers and reassigns to Assignor, without representation or warranty, all of the Collateral Agent's right, title and interest in, to and under the Pledged Trademarks.

The Collateral Agent hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release.
