## ASSIGNMENT

This Assignment ("Agreement") is entered into and effective as of October 8, 2004 and between Jason Enterprises, Inc., a corporation of Texas, having an office at 11445 Cronhill Drive, Owings Mills, Maryland ("Jason TX") and Medifast, Inc., having an office at 11445 Cronhill Drive, Owings Mills, Maryland ("Medifast").

WHEREAS, the assets of Jason Enterprises, Inc., a corporation of Texas, having an office at 11445 Cronhill Drive, Owings Mills, Maryland ("Jason TX") and a wholly-owned subsidiary of Medifast were transferred by operation of law to Medifast as a result of the corporate dissolution of Jason TX on or about October 8, 2004.

The Parties agree as follows:

### Article 1 - Definitions

- 1.1 "Marks" shall mean the marks identified on Attachment A hereto.
- 1.2 "Parties" shall mean the entities that, through their duly authorized representatives, having executed this Agreement.

### Article 2 - Transfers and Assignments

2.1 **Trademarks.** For good and valuable consideration, Medifast assigned and transferred to Jason DE the entire right, title, and interest in and to the Marks, together with that portion of the goodwill of the business associated with the use of and symbolized by the Marks, all common law rights in the Marks, and all causes of action, past, present, and future for infringement of the Marks.
