## GENERAL ASSIGNMENT OF INTANGIBLE PERSONAL PROPERTY

KNOW ALL MEN BY THESE PRESENTS that as of this 27 day of August, 2010, LH BRAZOS HOLDING, LP, a Delaware limited partnership ("LHBH"), LH DRSKL OPERATING, LLC, a Delaware limited liability company ("LHDO") and DESTINATION BRAZOS MANAGEMENT, INC., a Texas corporation ("**Destination**" and together with LHBH and LHDO, the "**Assignor**"), in consideration of Ten Dollars and other good and valuable consideration paid by LH-JV CDVIII DRISKILL OPERATING, LLC, a Delaware limited liability company ("**Operating Assignee**"), the receipt and sufficiency of which is hereby acknowledged, hereby assigns unto Operating Assignee all of the Assignor's right, title and interest in and to all of the following intangible personal property included in the assets of property known as The Driskill Hotel, located in Austin, Texas (the "**Hotel**") which are being sold pursuant to a Purchase and Sale Agreement dated June 4th, 2010 among LHBH and LHDO, as seller, and Operating Assignee and LH-JV CDVIII Driskill Holding, LP, a Delaware limited partnership ("**Holding Assignee**"), as purchaser ("**Purchase Agreement**"): (i) all brochures, promotional and marketing materials, books, records, reservation registers, files, and documents related to ongoing operation at the Hotel, (ii) telephone numbers, post office and web addresses used for the Hotel, (iii) all of the books, records, correspondence and other files, both paper and electronic, which have been received or generated and maintained in the course of operation of the Hotel and which are in the possession and control of Assignor including the guest register (collectively, the "**Operating Intangible Personal Property**").

Assignor, in consideration of Ten Dollars and other good and valuable consideration paid by Holding Assignee, (collectively with Operating Assignee, the "**Assignees**"), the receipt and sufficiency of which is hereby acknowledged, hereby assigns unto Holding Assignee all of the Assignor's right, title and interest in and to all of the following intangible personal property included in the assets of the Hotel, which are being sold pursuant to the Purchase Agreement: (i) any trade names, trademarks, and trademark registrations and applications therefor, service marks, domain names, logos, copyrights, copyright registrations and other forms of identification used to identify the Hotel (including the name "Driskill Hotel" and the right to continue to use such name) or any of its facilities or operations, and the names used to designate the restaurant and bar facilities with the Hotel, and the goodwill associated therewith, (ii) any plans and specifications for the Improvements (as such term is defined in the Purchase Agreement), and (iii) any studies, analyses, reports and other written materials pertaining to the condition of the Improvements and Land (as such term is defined in the Purchase Agreement), (collectively, the "**Holding Intangible Personal Property**").

TO HAVE AND TO HOLD the same unto the Assignees, their successors and assigns from and after the date hereof, subject to the terms, covenants, conditions and provisions contained in the Purchase Agreement.

Assignees hereby accept such assignments and hereby assume all of the rights, obligations and liabilities of Assignor, accruing from and after the date hereof, with respect to the Operating Intangible Personal Property and the Holding Intangible Property.

This Assignment is made without warranty or representation by, or recourse against the

Assignor except as set forth in the Purchase Agreement. Nothing in this Assignment shall be deemed to limit, waive or otherwise derogate from any provision of the Purchase Agreement and none of such provisions in the Purchase Agreement shall be deemed to have merged into this Assignment.

This Assignment shall be binding upon and shall inure to the benefit of Assignor and Assignees, their respective successors and assigns.

This Assignment may be executed in any number of counterparts, each of which shall be an original, but all of which shall constitute one instrument, and it shall be sufficient if any party hereto signs any such counterpart, so long as each of the parties hereto executes at least one such counterpart.
