Pursuant to TMEP Section 503.06(c), Registrant, Busch Properties, Inc., by and through its counsel, submits this Declaration in support of its request to correct the chain-of-title for U.S. Reg. No. 1167639. The chain-of-title currently reflected in the USPTO's records for that registration contains an error that apparently arose because the registration was not divided into "parent" and "child" registrations in advance of the recordal of an assignment of a portion of that registration, which portion is now in the "child" registration.

Declaration

- 1. Pursuant to the records of the United States Patent and Trademark Office (the "USPTO"), Busch Properties, Inc. obtained Reg. No. 1167639 on Sept. 1, 1981 for the mark KINGSMILL in three classes, namely Classes 36, 41, and 42.
- 2. On July 30, 2011, Busch Properties, Inc. and Xanterra Kingsmill, LLC entered into a United States Assignment Agreement, whereby Busch Properties, Inc. agreed to assign certain trademarks in certain classes of goods/services to Xanterra Kingsmill, LLC (the "Assignment Agreement"). A copy of that Assignment Agreement is attached.
- 3. That Assignment Agreement specifies that only Classes 41 and 42 of Reg. No. 1167639 are assigned to Xanterra Kingsmill, LLC, and further specifies that Class 36 of that registration is to remain with Busch Properties, Inc.
- 4. On July 30, 2011, Busch Properties, Inc. filed a Divisional Request with the USPTO for Reg. No. 1167639 to divide out Classes 41 and 42 (a copy of which is attached), and also submitted the Assignment Agreement for recordal with the Assignment Division of the USPTO.
- 5. The Assignment Division recorded the Assignment Agreement at Reel 004251, Frame 0658 on July 30, 2010, long before the Divisional Unit's completion of the Divisional Request on March 30, 2011, such that all three classes of the original Reg. No. 1167639 were placed in the name of Xanterra Kingsmill, LLC prior to the division of the *original* Reg. No. 1167639 into separate registrations, namely *parent* Reg. No. 1167639 covering Class 36 and *child* Reg. No. 3939343 covering Classes 41 and 42.

- 6. Accordingly, ownership of the *parent* registration, Reg. No. 1167639, has inadvertently and mistakenly been placed in the name of Xanterra Kingsmill, LLC.
- 7. Busch Properties, Inc. confirms that it is the original registrant of Reg. No. 1167639 and that it has been and continues to be the owner of *parent* Reg. No. 1167639.
- 8. Busch Properties, Inc. respectfully requests correction of the USPTO's records to reflect ownership of the *parent* registration, Reg. No. 1167639, in the name of Busch Properties, Inc.


