**CERTIFICATE OF CONVERSION  
OF  
DAVIS-LYNCH, INC.**

Pursuant to the provisions of Section 10.101 of the Texas Business Organizations Code (the "TBOC"), the undersigned converting entity, Davis-Lynch, Inc., a Texas corporation (the "Company"), hereby certifies to and authorizes the filing with the Secretary of State of Texas the following Certificate of Conversion for the purpose of converting the Company into the converted entity, Davis-Lynch, LLC, a Texas limited liability company.

**ARTICLE ONE**

The name of the converting corporation is "Davis-Lynch, Inc." The Company was formed as a Texas corporation on February 4, 1947 and was assigned file number 8975700.

**ARTICLE TWO**

The Company is converting to a limited liability company. The name of the limited liability company is "Davis-Lynch, LLC" and such limited liability company shall be formed under the laws of the State of Texas.

**ARTICLE THREE**

A signed plan of conversion is on file at the Company's principal place of business at 2700 Post Oak Boulevard, Suite 1050, Houston, Texas 77056. A signed plan of conversion will be on file after the conversion at the principal place of business of the limited liability company, the converted entity, at 2700 Post Oak Boulevard, Suite 1050, Houston, Texas 77056. A copy of the plan of conversion will be furnished on written request without cost by the Company before the conversion or by the limited liability company, the converted entity, after the conversion to any owner or member of the Company, the converting entity, or the limited liability company, the converted entity.

**ARTICLE FOUR**

The converted entity is a Texas limited liability company. The Certificate of Formation of the converted entity is attached hereto Exhibit "A".

**ARTICLE FIVE**

The plan of conversion has been approved as required by the laws of the State of Texas and the governing documents of the Company.

**ARTICLE SIX**

The conversion of the Company into Davis-Lynch, LLC shall become effective on June 23, 2011, at 12:01 a.m.

**ARTICLE SEVEN**

In lieu of providing a tax certificate from the Comptroller of Public Accounts of the State of Texas stating that all taxes under Title 2, Tax Code, have been paid by the Company, the limited liability company as the converted entity is liable for the payment of any franchise taxes.

The undersigned signs this document subject to the penalties imposed by law for the submission of a materially false or fraudulent instrument.
