RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, **ASCENTA THERAPEUTICS, INC.**, a Delaware corporation with offices located at 101 Lindenwood Drive, Suite 405, Malvern, Pennsylvania 19355 ("**Grantor**"), granted a security interest in and lien upon certain trademarks and related rights to **SILICON VALLEY BANK**, a California corporation, with its principal place of business at 3003 Tasman Drive, Santa Clara, California 95054 and with a loan production office located at 100 Matsonford Road, Building 5, Suite 555, Radnor, Pennsylvania 19087 ("**SVB**") as collateral agent (the "**Collateral Agent**") for the ratable benefit of SVB and **OXFORD FINANCE LLC**, successor in interest to Oxford Finance Corporation ("**Oxford**", and together with SVB, the "**Lenders**"), a Delaware limited liability company with an office at 133 North Fairfax Street, Alexandria, Virginia 22314, as set forth in a certain Intellectual Property Security Agreement, dated March 1, 2010, by and among Grantor, the Collateral Agent, and the Lenders (the "**Security Agreement**");

WHEREAS, an executed copy of the Security Agreement was recorded in the United States Patent and Trademark Office on March 15, 2010 at Reel 004167 Frame 0446;

WHEREAS, Grantor has requested that the Collateral Agent and the Lenders release and reassign their interests in the trademarks more fully identified in Schedule A annexed hereto and made a part hereof; and


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Collateral Agent and the Lenders each hereby:

1. releases and reassigns to Grantor any and all liens, security interests, right, title and interest of the Collateral Agent and the Lenders pursuant to the Security Agreement in the trademarks more fully identified in Schedule A, without recourse or representation or warranty, express or implied, of any kind;
2. agrees that any power of attorney or similar rights granted by Grantor to the Collateral Agent and the Lenders pursuant to or in connection with the Security Agreement is terminated; and
3. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.


