TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST

Effective as of the 15th day of January, 2010.

RETURN ON INNOVATION CAPITAL LTD. as agent for ROI FUND INC., ROI SCEPTRE CANADIAN RETIREMENT FUND, ROI GLOBAL RETIREMENT FUND and ROI HIGH YIELD PRIVATE PLACEMENT FUND and ANY OTHER FUND MANAGEMENT by ROI from time to time (hereinafter called "ROI")

IN FAVOUR OF:

GANDI INNOVATIONS LLC, a limited liability company organized under the laws of the State of Texas, by the BDO Canada Limited, solely in its capacity as Court-appointed monitor of Gandi Innovations LLC, and not in its personal capacity (hereinafter called "Gandi San Antonio")

RECITALS:

WHEREAS Gandi San Antonio is registered with the United States Patent and Trademark Office as the owner of the trade-marks listed on the attached Schedule "A" and the applications and registrations therefor (the "Trade-marks");

AND WHEREAS in accordance with the terms of the Intellectual Property Security Agreement between Gandi San Antonio and ROI dated May 22, 2008, Gandi San Antonio granted to ROI as security for certain financing arrangements with Gandi Innovations Limited as the borrower pursuant to a debenture agreement dated May 22, 2008, a security interest over the Trade-marks (such security interest hereinafter called the "Discharged Property"), as recorded with the U.S. Patent and Trademark Office on May 23, 2008 at Trademark Reel 3782 and Frame 0149;

AND WHEREAS, ROI has agreed to terminate and release its security interest and all of its right, title and interest in the Discharged Property as herein provided.

NOW THEREFORE for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ROI covenants and agrees as follows:

1. **Termination and Release of Security Interest:** ROI releases and discharges the Registered Security against the Discharged Property, and releases and discharges any and all other Security Interests it has in respect of the Discharged Property, and assigns and transfers to Gandi San Antonio, without recourse, all of ROI's right, title and interest in and to each of the Trade-marks and the appurtenant goodwill, and confirms and acknowledges that as of the effective date set forth herein, ROI no longer has any Security Interests in the Discharged Property.

2. Preamble and Schedules: The Recitals and Schedules attached hereto shall form part of this Termination and Release.


