ASSIGNMENT OF INTELLECTUAL PROPERTY IN THE UNITED STATES

WHEREAS Gandhi Innovations LLC (the “**Assignor**”) is registered with the United States Patent and Trademark Office as the owner of the trade-marks listed on the attached Schedule “A” and the applications and registrations therefor (the “**Trade-marks**”);

AND WHEREAS pursuant to an Order of the Honourable Madam Justice Hoy of the Ontario Superior Court of Justice (the “**Court**”) dated May 8, 2009 (as amended and restated) (the “**Initial Order**”), Gandhi Innovations Limited, Gandhi Innovations Holdings LLC, Gandhi Innovations Hold Co., Gandhi Special Holdings LLC and the Assignor (collectively, the “**Applicants**”) commenced proceedings (the “**CCAA Proceedings**”) pursuant to the *Companies' Creditors Arrangement Act* (Canada) and BDO Dunwoody Limited was appointed as monitor (the “**Monitor**”) in those proceedings;

AND WHEREAS pursuant to an Order of the United States Bankruptcy Court for the Western District of Texas, San Antonio Division (the “**U.S. Court**”) dated June 5, 2009, the CCAA Proceedings have been recognized as foreign main proceedings pursuant to chapter 15 of the United States Bankruptcy Code and the Initial Order has been given full force and effect in the United States;

AND WHEREAS pursuant to an Order of the Court dated November 25, 2009 and an Amended and Restated Approval and Vesting Order dated December 10, 2009 (together, the “**Sale and Vesting Order**”) the Court approved an Agreement of Purchase and Sale dated November 25, 2009, as amended by the Amending Agreement dated December 9, 2009 (the “**Agreement**”) among Agfa Inc. and Agfa Corporation (collectively, the “**Purchasers**”) and the Applicants, providing for the vesting in the Purchasers of the Applicants’ right, title and interest in and to the Purchased Assets (as such term is defined in the Agreement), including the Trade-marks, which vesting is to be effective with respect to the Purchased Assets upon the delivery by the Monitor to the Purchasers of a certificate confirming (i) the payment by the Purchasers of the purchase price for the Purchased Assets; (ii) that the conditions to Closing (as such term is defined in the Agreement) as set out in sections 4.1 and 4.3 of the Agreement have been satisfied or waived by the Monitor and the Purchasers; and (iii) the transaction has been completed to the satisfaction of the Monitor;

AND WHEREAS pursuant to “Order Enforcing And Recognizing The Orders Of The Ontario Court Approving The Sale Of Certain Assets” dated January 8, 2010, the Sale and Vesting Order was given full force and effect in the United States and the U.S. Court approved the sale, assignment and transfer of the U.S. Purchased Assets (as such term is defined in the Agreement) to the Assignee;


AND WHEREAS one of the conditions of Closing, among other things, is the delivery by the Applicants to the Purchasers of assignment(s) of the Intellectual Property (as such terms is defined in the Agreement) that is capable of registration in a form suitable for recordal in the applicable intellectual property office;

NOW THEREFORE, for good and valuable consideration paid by the Purchasers to the Assignor, the receipt and sufficiency of which is hereby acknowledged, the Assignor hereby assigns and transfers to Agfa Corporation (the "**Assignee**"), its successors and assigns, all of its right, title and interest in and to the Trade-marks in the United States, including the application therefor, together with the goodwill of the business symbolized by the Trade-marks, all rights of action resulting from prior infringement or other unauthorized use of the Trade-marks, and all rights as a party in any opposition or similar proceedings.
