TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made as of August 4, 2011 (the "Effective Date") between BOON, INC., an Arizona corporation ("Assignor"), and BKD ACQUISITION, INC., a Delaware corporation ("Assignee").

RECITALS

A. Pursuant to an Asset Purchase Agreement dated as of the date hereof (the "Asset Purchase Agreement"), by and between Assignor and Assignee and certain other parties, Assignee has agreed to purchase certain assets of Assignor, including the Assigned Trademarks (as defined below).

B. Assignor is the owner of the Assigned Trademarks provided that with respect to the common law marks set forth on Appendix A, Assignor's "ownership" of such marks is limited solely to the extent Assignor has any common law rights therein.

C. Assignor desires by execution of this Assignment to confirm the assignment of all of Assignor's rights, title and interest in and to the Assigned Trademarks to Assignee, and Assignee desires by execution of this Assignment to confirm the assignment of all of Assignor's rights, title, and interest in and to the Assigned Trademarks to Assignee.

AGREEMENT

For valuable consideration, including that recited in the Asset Purchase Agreement, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns the Assigned Trademarks as follows:

1. Definition of the Assigned Trademarks. The term "Assigned Trademarks" shall mean the common law trademarks, trademark applications and registrations listed in Appendix A attached hereto, as well as: (a) all common law rights therein; (b) all goodwill associated therewith; (c) all renewals thereof; and (d) all rights of action, powers and benefits accrued thereto, including the right to sue for and/or initiate any proceeding to collect damages and payments for past or future infringements thereof.

2. Assignment of the Assigned Trademarks. Assignor hereby sells, assigns and transfers to Assignee, its successors and assigns all of Assignor's right and title to and interest in the Assigned Trademarks.


