ASSIGNMENT AGREEMENT

THIS ASSIGNMENT AGREEMENT (this "Assignment") effective as of November 15, 2010 ("Effective Date") is made by and between

Agfa Corp., a corporation organized under the laws of the State of Delaware, having its offices at 100 Challenger Road, Ridgefield Park, 07660 New Jersey, USA (hereinafter referred to as "Assignor"), and

Agfa Graphics NV, a Belgian corporation with its principal place of business at Septestraat 27, 2640 Mortsel, Belgium (hereinafter referred to as "Assignee").

WHEREAS, Assignor, as buyer, is party to that certain Agreement of Purchase and Sale dated as of November 15, 2009 (the "Agreement"), which is incorporated herein by reference, pursuant to which Gandi Innovations Limited, Gandi Innovations LLC and Gandi Innovations Holding LLC (together "Sellers") have agreed to convey to Assignor certain assets, including certain trademarks, all as more particularly described in the Agreement.

WHEREAS, Agfa-Gevaert NV, the ultimate parent of both Assignor and Assignee, has concluded that it and its affiliates and subsidiaries benefit from centralized ownership and management of intellectual property related to trademarks and trade names and has therefore instituted a corporate policy that the ultimate parent of each of its businesses owns and manages all of the intellectual property related to trademarks and trade names of the respective businesses.

WHEREAS, Assignor desires to assign to Assignee all of Assignor's right, title and interest in and to the trademarks listed in the Schedule A attached hereto (the "Trademarks") that are conveyed under the Agreement.

NOW, THEREFORE, for and in consideration of the premises and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Assignor and Assignee hereby agree as follows:

1. Assignor hereby assigns to Assignee, its successors and assigns, all of Assignor's right, title and interest in and to the Trademarks.
2. Assignee shall succeed to all of the rights of Assignor in and to the Trademarks, and assume all of the liabilities and obligations pertinent to the Trademarks.
2. Assignor agrees to execute any documents reasonably necessary to effect this assignment or to confirm Assignee's ownership of the Trademarks.
3. This Assignment may be executed in multiple counterparts, each of which shall constitute an original, and all of which taken together shall constitute one and the same instrument. Counterparts of this Assignment may be executed and delivered by facsimile or email transmission, and a facsimile or a scanned signature transmitted via email shall be binding on such party as if it were an original thereof.
4. This Assignment shall be governed by and construed in accordance with the laws of the State of New Jersey irrespective of any conflict of law principles that would result in the application of the laws of another jurisdiction, including the validity of this Assignment, the

construction of its terms, and the interpretation and enforcement of the rights and duties of the parties hereto.
