## INTELLECTUAL PROPERTY ASSIGNMENT

This Intellectual Property Assignment (the "Assignment") is entered into as of October 22, 2009 (the "Effective Date"), by and between **BUSH HOG, LLC**, a Delaware limited liability company ("Assignor"), and **ALAMO ACQUISITION, INC.**, a Delaware corporation ("Assignee").

Pursuant to that certain Asset Purchase Agreement (the "Purchase Agreement") dated as of September 4, 2009, by and among Assignor, Assignee, CCI and AGI, Assignor has sold to Assignee all right, title and interest in and to the Intellectual Property included in the Purchased Assets (collectively, the "Transferred Intellectual Property"), including but not limited to as referenced on Exhibit A. Capitalized terms used but not otherwise defined herein shall have the meanings ascribed thereto in the Purchase Agreement.

NOW, THEREFORE, in consideration of the premises and the mutual agreements and covenants set forth in the Agreement and hereinafter set forth, the parties hereby agree as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby:

(a) sell, transfer, assign, convey and deliver to Assignee, and its successors and assigns, all of its right, title and interest in and to the Transferred Intellectual Property, together with the associated goodwill therewith; and

(b) authorize Assignee to effectuate the Assignment of registered patents and trademarks constituting Transferred Intellectual Property with the United States Patent and Trademark Office or foreign equivalent.

2. Further Assurances. Assignor shall perform such acts as Assignee may reasonably request to vest title to the Transferred Intellectual Property in Assignee.

3. Miscellaneous.

(a) Entire Agreement. This Assignment shall be subject to all of the terms and conditions of the Purchase Agreement. In the event of a conflict between this Assignment and the Purchase Agreement, the terms of the Purchase Agreement shall control.

(b) Succession and Assignment. This Assignment shall be binding upon and inure to the benefit of the parties named herein and their respective successors and assigns.

(c) Counterparts. This Assignment may be executed in counterparts, each of which shall constitute an original, but both of which, taken together, shall constitute one instrument.




