## TRADEMARK ASSIGNMENT

WHEREAS, WYRESTORM TECHNOLOGIES, LLC, a Tennessee limited liability company ("Assignee"), of Memphis, County of Shelby, State of Tennessee, with its principal office at 6755 Buckles Cove, Memphis, TN 38133, is desirous of acquiring the entire right, title and interest in and to the WYRESTORM trademark and the BRINGING THE ELEMENTS TO YOU IN HIGH DEFINITION trademark application;

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged by Assignor by these presents does hereby sell, assign, convey and transfer unto the said Assignee all of Assignor's title and interest in and to (1) the WYRESTORM trademark, (2) the BRINGING THE ELEMENTS TO YOU IN HIGH DEFINITION trademark application and also its entire right, title, and interest in and to any trademark registration that may be granted therefore by the Trademark Office, and (3) all of the goodwill associated with said marks.

Assignor hereby authorizes and requests the Trademark Office's Commissioner for Trademarks to record the assignment to Assignee of the ownership of the WYRESTORM trademark and the BRINGING THE ELEMENTS TO YOU IN HIGH DEFINITION trademark application to Assignee, with such ownership including the entire right, title and interest in and to the same for Assignee's sole use and benefit; and for the use and benefit of its legal representatives, assigns, and/or successors, to the full end of the term and any extensions thereof for which any and all trademarks may be

granted, as fully and entirely as the same would have been held by Assignor had this assignment not been made.

And, Assignor hereby covenants and agrees that Assignor will execute and deliver further instruments of assignment and transfer as Assignee may reasonably request to more effectively transfer and assign to Assignee each of the aforesaid trademarks..

This Trademark Assignment will be interpreted in accordance with the United States of America's Federal trademark laws and the laws of the State of Tennessee, to the extent that state law is applicable. .
